
WE BELIEVE that all men are fallen in sin and totally depraved.

Tecate Mission International Faith Mission

Tecate Mission International is a non-profit, faith mission agency with all staff and personnel considered as faith missionaries. In answer to prayer and through the Lord's provision, funds are raised for TMI from interested churches, groups and individuals.



Tecate Mission International depends upon God for the supply of its needs. These needs and projects are presented first to the Lord, but also at appropriate times in churches, through the *Tecate Mission Int'l News*, and through individual missionary communications. As a donor, your involvement through prayer, financial giving, and other personal contributions of articles or labor can make a difference in the lives of many people whom Christ loves and for whom He died.

Missionary Responsibility

A missionary making application to TMI must discuss with leadership a projected cost for ministry and living expenses in the area of service. There should be an understanding that different ministries require different expenditures. Upon approval of the leadership, the missionary may begin to raise this estimated funding. TMI considers the 'goer' and the 'sender' of equal importance in the missionary cause therefore a partnership is formed in order to serve together.

Medical Insurance is strongly encouraged of all missionaries making application to TMI. All payments and premiums related to medical insurance and retirement planning will be the personal responsibility of the missionary.

Each TMI missionary should communicate gratitude for all donations designated to his/her account.

In the event that a missionary terminates his/her ministry with TMI, donors must be informed. Donations designated for the terminated ministry or project will either be returned to the donors or re-routed to other ministries at the discretion of TMI. Designated donations will be processed for missionaries for 30 days following the resignation date.

Financial Statement

Tecate Mission International is an IRS 501 (c) (3) tax-exempt corporation, and all tax deductible contributions are acknowledged with an official tax deductible receipt. The goal is to uphold the highest standards of financial integrity in the daily operation of TMI.

Even thou individual missionaries are involved in this fund-raising process, the donor must always consider his/her donation as being made to TMI and not to an individual. All funds are the property of TMI. In accordance with IRS regulation 501 (c) (3), this organization retains the right to determine the use of any and all funds, while attempting to respect the suggested designation given. Funds are acknowledged with an official receipt for tax purposes.

It is the stated decision of the Executive Board to comply with all the IRS requirements for a non-profit organization.

Each missionary is required to take care of his/her own income tax for each year. At the time of becoming a member, information will be required by the TMI Finance Office for IRS purposes.
